FORMAT REGULATIONS FOR CONFERENCE PROCEEDINGS PAPERS

Page 1 (Introduction)

- · Author's name
- · Affiliation
- · Contact information: Address, email, phone number
- · Author's research field
- · Title of the paper
- Topic (Choose one of the conference topics)
- · Research field of the paper
- · Word count of the paper
- Abstract: The abstract section must be written concisely in one paragraph (150 to 200 words), reflecting the main contents of the paper and demonstrating the results, contributions, and new points.

From page 2 (Content)

- Title: The article title should be no more than 20 words, reflecting the article's content directly. The title must be in capital letters, bold, and centered on the page, for example:
- Summary: The summary must be written in a short paragraph (150 to 200 words), reflecting
 the main contents of the article and clearly showing the results, contributions, and new points
 of the article.
- Keywords: The author needs to provide 3-5 keywords of the article in alphabetical order, showing the characteristics of the article's topic

Note: For articles written in Vietnamese, the author is required to provide the title and summary (including keywords) translated into English and presented immediately below the summary

- · Article structure must include five main sections:
- 1. Introduction or problem statement: (i) the reason for conducting this research and the importance of the research topic; (ii) identifying the research problem; (iii) the main content that the article will focus on resolving.
- 2. Literature review, theoretical framework, and research methods: (i) presenting a clear overview of the research and related theoretical foundation; (ii) the theoretical or analytical framework used in the article; (iii) the author can choose qualitative or quantitative research methods or both,

Depending on the approach they choose, they need to show the model, research hypotheses, and data collection methods.

- 3. Results and discussion: (i) interpreting and analyzing new findings; (ii) drawing the general relationship and connection between the author's research results and the findings of other studies.
- 4. Conclusion and research implications: depending on the research objective and theoretical implications, the article needs to have conclusions and provide recommendations for business managers and policymakers based on the research results.
- 5. References: The author only lists the sources cited in the article. The specific citation and reference list presentation formats are regulated in section 4.3.

Presentation technique:

- 1. The article should be presented in Vietnamese or English using MS Word format, A4 paper size, with a typical length of 8 to 15 pages; font: Times New Roman, font size: 12pt; margins: left 3cm, right, top, bottom: 2cm; paragraph: before 3pt, after 3pt; line spacing: 1.3pt Multiple.
- 2. Numbering of headings: In the main content of the article, significant headings should be bold, left-aligned, and continuously numbered using Arabic numerals. Level 1 subheadings (e.g., 2.1) should be bold and italicized, and level 2 subheadings (e.g., 2.1.1) should be italicized but not bold.
- 3. Presentation of tables and figures: Data tables presented in the article should be uniformly labeled as "Table." Data tables should be formatted as a table in Microsoft Word. The article's graphs, charts, and diagrams should be uniformly labeled as "Figure." Tables and figures in the article should be numbered separately and continuously using Arabic numerals, and the sequence number should be placed after the word "Table" or "Figure" (e.g., Table 1, Table 2, Figure 1, Figure 2). Each table/figure must have a corresponding name that accurately describes its contents. The sequence number and name of the table/figure should be placed horizontally at the top of the table/figure in bold letters. Tables/figures in the article must be cited. The source should be placed at the bottom of the table/figure, with the presentation in italics but not bold. Notes should also be included to explain the table/figure further when necessary.
 - 4. Citation and reference list formatting should follow APA standards.

Similarity check:

- 1. Papers submitted to the conference will be checked for similarity in advance by, for example, Turnitin or iThenticate.
- 2. Papers with a higher than 25% Similarity Index will not be accepted for the conference (references are not counted during the similarity check).
